- We have established and publicly published standards to prevent child sexual abuse and exploitation. These standards are integrated into our community guidelines and terms of use.

- All users are informed about these standards upon registration and periodically through updates on our platform.

## 4.2 In-App and On-Site Reporting and Feedback Mechanism

- **User Feedback:** A dedicated feedback mechanism is available for users to report concerns, inappropriate content, or suspicious behavior via our “Report an Issue” feature. All reports are reviewed promptly by our safety team.
- **Accessibility:** Reporting tools are designed to be easily accessible and user-friendly to encourage swift reporting by community members.

## 4.3 Addressing Child Sexual Abuse Material (CSAM)

- **Zero Tolerance:** Any content identified as CSAM will be immediately removed from the platform. We employ both automated systems and manual reviews to detect and block prohibited content.

- **Collaboration:** If a report indicates a serious risk to a child, we will collaborate with law enforcement and child protection agencies.
- **Content Removal:** Confirmed instances of CSAM or other violations will be immediately removed from our platform, with further actions taken in line with legal obligations.

## 6. Education and Prevention

- **Staff Training:** Regular training is provided for all employees and moderators to recognize and respond to signs of child exploitation and abuse.
- **Community Resources:** We offer ongoing educational resources and safety tips to help our community adhere to our child safety standards.

## 7. Policy Updates and Review

- **User Notification:** Significant changes to the policy will be communicated via our website and in-app notifications.
